Notice of Initiation of Sunset Review of Anti-Dumping Duties Imposed on Dumped Imports of Cold Rolled Coils/Sheets Imported from People's Republic of China and Ukraine

National Tariff Commission (the "Commission") has received an application on November 30, 2020 under Section 58 of Anti-Dumping Duties Act, 2015 (the "Act") from M/s Aisha Steel Mills Limited, Karachi and M/s International Steel Limited, Karachi (the "Applicants") for review of the anti-dumping duties imposed on Cold Rolled Coils/Sheets ("CR Coils/Sheets") importable from the People's Republic of China and Ukraine (the "Exporting Countries"). The application is filed in response to the notice of impending expiry of the anti-dumping duties imposed on CR Coils/Sheets from the Exporting Countries. The notice of impending expiry was published in the official Gazette and national press on October 09, 2020.

Product under Review: The product for which this Review has been requested is flat-rolled products of iron or non-alloy steel, cold-rolled (cold-reduced), not clad, plated or coated coils and sheets of prime and secondary quality of a thickness of 0.15 to 2.50 mm and width of above 600 mm. It is classified under Pakistan Customs Tariff ("PCT") No. 7209.1610, 7209.1690, 7209.1710, 7209.1790, 7209.1810, 7209.1891, 7209.1899, 7209.2610, 7209.2690, 7209.2710, 7209.2790, 7209.2810 and 7209.2890. It is used for fabrication of steel products for construction, storage racks, automotive parts and bodies, railway coaches, highway products, transmission towers, transmission poles, pipes, household products, firearms, various types of equipment etc.

Period for Review (POR): The sunset review would be conducted on the basis of information for the last three years i.e. from October 1, 2017 to September 30, 2020.

Basis for Review: The Applicants have claimed that there is likelihood of continuation or recurrence of dumping of the product under review into Pakistan by the exporters/foreign producers from the Exporting Countries which may lead to continuation or recurrence of injury to the domestic industry. The Applicants have provided in application sufficient information and evidence in accordance with provisions of the Act.

Initiation of Review: Upon initial examination of the information and evidence provided in application, the Commission is satisfied that the application *prima facie* qualifies as a duly substantiated request under Section 58 of the Act. Therefore, the Commission hereby initiates a Review pursuant to Section 58 of the Act to determine whether expiry of the anti-dumping duties imposed on imports of CR coils/sheets from the Exporting Countries would likely to lead to continuation or recurrence of dumping of the product under review and injury to the domestic industry, or not.

Continuation of Anti-dumping Duties: In terms of Section 58(3) of the Act, the anti-dumping duties imposed on dumped imports of CR coils/sheets from the Exporting Countries will remain in-force pending the outcome of the review.
