**Notice of Initiation of Sunset Review of Anti-Dumping Duties Imposed on
Dumped Imports of Offset Printing Ink Originating in and/or Exported
from the People's Republic of China and the Republic of Korea**

National Tariff Commission (the "Commission") has received an application on May 28, 2022 under Section 58 of Anti-Dumping Duties Act, 2015 (the "Act") from M/s DIC Pakistan Limited, Lahore (the "Applicant") for review of the anti-dumping duties imposed on offset printing ink ("OPI") importable from the People's Republic of China, the Republic of Korea (the "Exporting Countries"). The application is filed in response to the notice of impending expiry of the anti-dumping duties imposed on OPI from the Exporting Countries. The notice of impending expiry was published in the official Gazette and national press on April 14, 2022.

Product under Review: The product for which this Review has been requested is offset printing ink in the form of paste also known as paste ink or oil based offset printing ink, but does not include water based, UV based, solvent based, flexographic rotogravure and other inks in liquid, powder or solid form ("OPI"). The said product is classified under Pakistan Customs Tariff ("PCT") Nos. 3215.1110, 3215.1190, 3215.1910 and 3215.1990. It is mainly used for printing and publishing of packaging material, POS printing, text books etc.

Period for Review (POR): The sunset review would be conducted on the basis of information for the last three years i.e. from April 1, 2019 to March 31, 2022.

Basis for Review: The Applicant have claimed that there is likelihood of continuation of dumping of the product under review into Pakistan by the exporters/foreign producers from the Exporting Countries which may lead to continuation or recurrence of injury to the domestic industry. The Applicant have provided in application sufficient information and evidence in accordance with provisions of the Act.

Initiation of Review: Upon initial examination of the information and evidence provided in application, the Commission is satisfied that the application *prima facie* qualifies as a duly substantiated request under Section 58 of the Act. Therefore, the Commission hereby initiates a Review pursuant to Section 58 of the Act to determine whether expiry of the anti-dumping duties imposed on imports of OPI from the Exporting Countries would likely to lead to continuation or recurrence of dumping of the product under review and injury to the domestic industry, or not.

Continuation of Anti-dumping Duties: In terms of Section 58(3) of the Act, the anti-dumping duties imposed on dumped imports of OPI from the Exporting Countries will remain in-force pending the outcome of the review.

Date of initiation of the review:	The date of publication of this notice in the press in Pakistan
Date of conclusion of review:	Within twelve months of the date of publication of notice of initiation of the review.

All written submissions provided by interested parties on a confidential basis must be marked "Confidential" and in accordance with Section 31 of the Act, shall be accompanied by a non-confidential version/summary, which will be placed in the public file. Hearing: Any party as defined in Section 2(j) of the Act may, if so wishes, request a hearing in accordance with Rule 14 of the Anti-Dumping Duties Rules, 2001 ("the Rules") within 30 days of the publication of this notice by contacting Secretary of the Commission.

Public File: In accordance with Rule 7 of the Rules, the Commission has established and shall maintain a public file at its office, which shall be available to interested parties for review and copying from Monday to Thursday between 1100 hours to 1300 hours (except public holidays) throughout the review.
