Notice of Initiation of Sunset Review of Anti-Dumping Duty Imposed on Dumped Imports of Deformed Concrete Reinforcing Steel Bars into Pakistan Originating in and/ or Exported <u>from the People's Republic of China</u>

National Tariff Commission (the "Commission") has received an application on July 18, 2022 under Section 58 of Anti-Dumping Duties Act, 2015 (the "Act") from M/s Amreli Steels Limited, Karachi, M/s Agha Steel Industries Limited, Karachi and M/s Mughal Iron &Steels Industries Limited, Lahore (the "Applicants") for review of the anti-dumping duty of 19.15% imposed on deformed concrete reinforcing steel bars ("Rebars") importable from the People's Republic of China ("China"). The application is filed in response to the notice of impending expiry of the anti-dumping duty imposed on Rebars from China. The notice of impending expiry was published in the official Gazette and national press on June 04, 2022.

Product under Review: The product for which this review has been requested is deformed steel concrete reinforcing bars ("Rebar") in straight lengths, U-bends or coils. Such deformed steel concrete reinforcing bars are in various diameters up to and including 40 MM, in various finishes including indentation, ribs, groves or other deformations excluding plain round bars, imported from China. The raw materials used in production Rebars are steel billets. It is classified under Pakistan Customs Tariff ("PCT") No. 7214.2010, 7214.2090, 7214.3010, 7214.3090, 7214.9910, 7214.9990, 7215.1010, 7215.1090, 7215.5010, 7215.5090, 7215.9010, 7215.9090, 7228.2090, 7228.3090, 7228.1000, 7228.4000, 7228.5000, 7228.6000.

Period for Review (POR): The sunset review would be conducted on the basis of information for the last three years i.e. from July 01, 2019 to June 30, 2022.

Basis for Review: The Applicants have claimed that there is likelihood of continuation or recurrence of dumping of the product under review into Pakistan by the exporters/foreign producers from China which may lead to continuation or recurrence of injury to the domestic industry. The Applicants have provided in application sufficient information and evidence in accordance with provisions of the Act.

Initiation of Review: Upon initial examination of the information and evidence provided in application, the Commission is satisfied that the application *prima facie* qualifies as a duly substantiated request under Section 58 of the Act. Therefore, the Commission hereby initiates a Review pursuant to Section 58 of the Act to determine whether expiry of the anti-dumping duties imposed on imports of Rebars from China would likely to lead to continuation or recurrence of dumping of the product under review and injury to the domestic industry, or not.

Continuation of Anti-dumping Duty: In terms of Section 58(3) of the Act, the anti-dumping duty imposed on dumped imports of SA from the Exporting Countries will remain in-force pending the outcome of the review.
