**Notice of Initiation of Second Sunset Review of Anti-Dumping Duty Imposed on Dumped Imports of Continuous Casting (Steel) Billets Originating in and/or Exported from the People's Republic of China.**

National Tariff Commission (the "Commission") has received an application on April 30, 2025, under Section 58 of the Anti-Dumping Duties Act, 2015 (the "Act") and Rule 32 of the Anti-Dumping Duties Rules, 2022 (the "Rules") from M/s. Amreli Steels Limited, Karachi, M/s. Mughal Iron & Steel Industries Limited, Lahore, and M/s Frontier Foundry Steel Private Limited, Peshawar (the "Applicants") for Review of the anti-dumping duty imposed on dumped imports of Continuous Casting (Steel) Billets ("CC Billets") into Pakistan originating in and/or exported from the People's Republic of China ("China"). The Applicants are the domestic producers of CC Billets. The application is filed in response to the Commission's notice of impending expiry of the anti-dumping duty imposed on CC Billets from China, published in the official gazette and national press on March 18, 2025.

**Product under Review:**

The product under Review is continuous casting (steel) billets ("CC Billets") originating in and/or exported from China to Pakistan, (the "product under Review"). It is a semi-finished product of iron and non-alloy steel, and alloy steel. The said product is classified under Pakistan Customs Tariff Heading Nos. 7207.1110, 7207.1190, 7207.1210, 7207.1290, 7207.1910, 7207.1920, 7207.1990, 7207.2010, 7207.2020, 7207.2090, 7224.1000, and 7224.9000. The product under review is used by the re-rolling mills in production of steel bars, wire rods, beams, channels, T-iron etc.

**Period of Review ("POR"):**

The sunset review would be conducted on the basis of information for the last three years i.e. with effect from January 01, 2022, to December 31, 2024.

**Basis for Review:**

The Applicants have claimed that there is a likelihood of continuation or recurrence of dumping of the product under review into Pakistan by the exporters/foreign producers from China, which may lead to continuation or recurrence of injury to the domestic industry. The Applicants have provided information and evidence in accordance with the provisions of the Act and Rules.

**Initiation of Review:**

Upon initial examination of the information and evidence provided in the application, the Commission is satisfied that the application *prima facie* justifies the initiation of a Review under Section 58 of the Act. Therefore, the Commission has decided to initiate a sunset review pursuant to Section 58 of the Act to determine whether expiry of the anti-dumping duty imposed on dumped imports of CC Billets from China would likely lead to the continuation or recurrence of dumping of the product under review and injury to the domestic industry.

**Continuation of Anti-dumping Duty:**

The anti-dumping duty on the dumped import of CC Billets from China is currently enforced till June 21, 2025. In terms of Section 58(3) of the Act, the anti-dumping duty will remain enforced pending the outcome of this Review.

**Schedule of Review:**

Date of initiation of the Review: The date of publication of this notice in the press in Pakistan  
Date of conclusion of Review: Within twelve months of the date of publication of notice of initiation of the Review.
