Notice of Initiation of Inquiry for Review of Tariff Structure on Blankets and its Raw Materials.

National Tariff Commission (the “Commission”) has received the applications under Section 9 of the National Tariff Commission Act, 2015 (the “Act”) and Rule 4 of the National Tariff Commission (Procedure) Rules, 2023 (the “Rules”) from M/s HBK Blanket Industries (Pvt.) Ltd. and M/s Pak Xuri Blanket Textile Mill (Pvt.) Ltd. (the “Applicants”) for review of tariff structure on Blankets (PCT No, 6301.9000), Semi Finished Blankets (PCT. No. 6001.9290) and its raw materials i.e. White Fabric for Blanket manufacturing (PCT No. 6001.9990). The Applicants are the domestic producers of Blankets.

Applicants Request:

The Applicants have requested to reduce customs duty on its raw material (White Fabric for Blanket manufacturing PCT No. 6001.9990) or increase tariff on semi-finished blankets (PCT. No. 6001.9290). The Applicants have based their requests on the following:

- a. At present, the applicable tariff rates on both semi-finished blanket fabric (classified under the relevant HS Code 6001.9290) and raw material in the form of white fabric for blanket manufacturing (under the HS Code 6001.9990) are identical, with a Customs Duty (CD) of 11% and an Additional Customs Duty (ACD) of 2%. This uniform tariff structure discourages local manufacturing, as it incentivizes importers to procure finished blankets from abroad rather than investing in domestic production or sourcing from locally manufactured goods.
- b. The domestic producers of blankets (PCT No, 6301.9000) have sufficient capacity to meet local demand.

Product under Investigation:

The products for which this Inquiry is initiated are Blankets, classified under PCT No, 6301.9000, Semi Finished Blankets (PCT. No. 6001.9290) and its raw materials i.e. White Fabric for Blanket manufacturing (PCT No. 6001.9990) (the “product under investigation”). Blankets are used in the household and hospitality industry while Semi Finished Blankets (PCT. No. 6001.9290) and its raw materials i.e. White Fabric for Blanket (PCT No. 6001.9990) are used for Blanket manufacturing.

Initiation of Investigation:

The Applicants have filed properly documented applications. Upon initial examination of the information and evidence provided in the applications, the Commission has decided to initiate an investigation pursuant to Rule 5(1) of the Rules.
