

**Notice of Initiation of Second Sunset Review of Anti-Dumping Duties Imposed on Dumped Imports of Cold Rolled Coils/Sheets into Pakistan Originating in and/ or Exported from the People's Republic of China**

The National Tariff Commission (the "Commission") received an application on November 24, 2025, under Section 58 of the Anti-Dumping Duties Act, 2015 (the "Act") and Rule 32 of the Anti-Dumping Duties Rules, 2022 (the "Rules") from M/s Aisha Steel Mills Limited, Karachi, and M/s International Steel Limited, Karachi (the "Applicants") for sunset review of anti-Dumping duties imposed on dumped imports of Cold Rolled Coils/Sheets ("CR Coils/Sheets") from the People's Republic of China ("China") into Pakistan. The Applicants are domestic producers of CR Coils/Sheets. The application is filed in response to the notice of impending expiry of the anti-dumping duties imposed on dumped imports of CR Coils/Sheets from China. The notice of impending expiry was published in the official Gazette and national press on October 11, 2025.

**Product under Review:** The product subject to anti-dumping duties is- flat-rolled products of iron or non-alloy steel of a thickness ranging from 0.15 mm to 3.00 mm and a width up to 1250 mm, cold- rolled (cold- reduced), not clad, plated or coated, of prime and secondary quality ("CR Coils/Sheets"), in rolls or slit to length sheets, excluding CR Coils/ Sheets used in automotive outer skins of four wheeler vehicles of following auto grades and Tin Mill Black Plate (TMBP) imported from China:

The CR Coils/Sheets are classified under Pakistan Customs Tariff Heading Nos. 7209.1510, 7209.1590, 7209.1610, 7209.1690, 7209.1710, 7209.1790, 7209.1810, 7209.1899, 7209.2510, 7209.2590, 7209.2610, 7209.2690, 7209.2710, 7209.2790, 7209.2810 and 7209.2890. The CR Coils/Sheets are generally used in production of automotive parts, sub-assembly/inner body parts, fabrication of goods like doors/cabinets, pipes, tubes, refrigerators, washing machines, geysers, ovens etc.

**Period for Review:** The sunset review would be conducted on the basis of information for the last three years i.e. from October 01, 2022, to September 30, 2025.

**Basis for Review:**

The Applicants have claimed that the expiry of antidumping duties would be likely to lead to continuation of dumping into Pakistan by the exporters/producers from China and injury to the domestic industry.

**Initiation of Review:** Upon initial examination of the information and evidence provided in the application, the Commission is satisfied that the application *prima facie* contains sufficient evidence that justifies initiation of the sunset review under Section 58 of the Act and Rule 36 of the Rules. Therefore, the Commission has decided to initiate a sunset review pursuant to Section 58 of the Act to determine whether the expiry of the anti-dumping duties imposed on dumped imports of CR Coils/Sheets from China would be likely to lead to the continuation of dumping of CR Coils/Sheets and injury to the domestic industry.

**Continuation of Anti-dumping Duties:** The anti-dumping duties imposed on dumped imports of CR Coils/Sheets from China are currently in force till January 12, 2026. Further, in terms of Section 58(3) of the Act, the anti-dumping duties will remain enforced pending the outcome of the sunset review.

Date of initiation of the Review:	The date of publication of this notice in the press in Pakistan
Date of conclusion of Review:	Within twelve months of the date of publication of notice of initiation of the sunset review.

All interested parties are invited to make their views/comments known to the Commission, and to submit information and documents (if any) not later than 45 days of the date of publication of this notice in the press in Pakistan. All written submissions provided by interested parties on a confidential basis must be marked "Confidential" and in accordance with Section 31 of the Act, shall be accompanied by a non-confidential version/summary, which will be placed in the public file. **Hearing:**

Any party as defined in Section 2(j) of the Act may request for a hearing in accordance with Rule 14 of the Rules within 30 days of the publication of this notice through a letter addressed to the Secretary, National Tariff Commission.

In accordance with Rule 7 of the Rules, the Commission has established and shall maintain a public file at its office, which shall be available to interested parties for review and copying from Monday to Thursday between 1100 hours to 1300 hours (except public holidays) throughout the sunset review.
